CIRCULAR N° 5

Información relevante sobre los pagos a los clubes participantes en la fase centralizada y no centralizada y los pagos de solidaridad a los clubes no participantes en la UEFA Champions League Femenina 2023/24.

(Circular n.º 40/2023 de UEFA)

Por medio de la presente, la RFEF comunica a todos sus afiliados el contenido de la Circular UEFA n° 40/2023, publicada en fecha 17 de julio de 2023.

En la citada circular, la UEFA informa sobre la distribución de pagos a los clubes participantes en la fase centralizada y no centralizada y los pagos de solidaridad a los clubes no participantes en la UEFA Champions League Femenina 2023/24.

La cuantía total para distribuir en la temporada 2023/24 es de 24 millones de euros, derivado del beneficio neto de la Champions League femenina 2023/24; la venta de tickets para la final; inversión de UEFA; y financiación cruzada de competiciones UEFA masculina.

Sin embargo, considerando el panorama actual, y la alta volatilidad de los tipos de cambios y la incierta situación económica global se advierte a los clubes a que se tomen con prudencia las cantidades en forma de ingresos anticipados. La distribución final se basará en los pagos efectivamente recibido por UEFA.

De la cuantía, un 48% se destinará a los clubes participantes en la fase centralizada; 29% a los clubes participantes en la fase no centralizada; y el 23% restante a los clubes no participantes.

Distributions to clubs from the 2023/24 UEFA Women's Champions League
Payments for the centralised and non-centralised phases
Solidarity payments for non-participating clubs

Dear Sir or Madam,

We are pleased to provide you further information concerning the distributions to clubs from the 2023/24 UEFA Women's Champions League. Details of payments to clubs participating in the centralised and non-centralised stages, as well as solidarity payments to clubs not participating in the competition can be found below and are identical to the payments announced for the 2022/23 season.

2023/24 season

The total amount available for distribution is €24 million, which is derived as follows:

- i) the net revenue of the 2023/24 UEFA Women's Champions League,
- ii) the sale of tickets for the final,
- iii) UEFA investment,
- iv) cross-financing from the UEFA men's club competitions

However, given the current context, the continued high volatility of exchange rates and the unstable global economic situation we encourage all clubs to adopt a prudent approach when budgeting for their anticipated income, even for fixed amounts. Final distributions will be based on payments actually received by UEFA.

All the provisions below are therefore subject to final confirmation by UEFA and cannot be considered as guaranteed income until further notice.

Of the amount of €24 million, 48% (€11.5 million) will be distributed to clubs in the centralised phase, 29% (€7 million) will be distributed to clubs in the non-centralised phase and 23% (€5.6 million) will be set aside for non-participating clubs.

1. Payments to clubs participating in the centralised phase

The net amount distributed to clubs in the centralised phase will be split into two different pillars:

- 55% will be allocated to starting fees (€6.4 million);
- 45% will be allocated to performance-related fixed amounts (€5.1 million).

1.1 Starting fee (€6.4 million)

Each of the 16 clubs that qualify for the group stage can expect to receive a group stage allocation of **€400,000**, split into a down payment of **€300,000** and a balance of **€100,000**.

1.2 Fixed amounts (€5.1 million)

- Group stage performance bonuses will be paid for each match: **€50,000** per win and **€17,000** per draw. Undistributed amounts (€16,000 per draw) will be pooled and redistributed to the clubs with the twenty-five longest travel distances in round 1 and round 2 (see point 2 below).
- In addition, the group winner will receive a bonus of €20,000.
- Clubs that qualify for the knockout stage can expect to receive the following amounts:
 - qualification for the quarter-finals: €160,000 per club;
 - qualification for the semi-finals: €180,000 per club;
- The runner-up can expect to receive €200,000;
- The winners can expect to receive €350,000.

2. Payments to clubs participating in the non-centralised phase

The amount distributed to clubs in the non-centralised phase amounts to 29% of the total estimated amount. Based on the forecast of €24 million, this would amount to €7 million. This will be distributed to clubs participating in rounds 1 and 2 as follows:

- Round 1
 - the host team will receive €30,000;
 - the visiting teams will receive €65,000;
 - the group winner will receive a bonus of €15,000;
 - the group runner-up will receive a bonus of €10,000;
 - the third-placed team in the group will receive a bonus of €5,000;
 - the fourth-placed team in the group (if applicable) will receive a bonus of €1,000.
- Round 2
 - the defeated team will receive €140,000;
 - the winning team will receive €100,000.

In addition, given there will not be a preliminary round in the 2023/24 season, a contribution will be made to the clubs with the twenty-five longest travel distances in rounds 1 and 2, funded by savings made from the access list rebalancing as well as from savings in the group stage distributions, as mentioned in point 1.2 above. The amount of the contributions will be determined, and payments made, in February 2024 after completion of the group stage.

3. Solidarity payments to clubs not participating in the UEFA Women's Champions League

The solidarity payments to non-participating clubs will represent 23% of the total estimated amount. A total of €5.6 million will be distributed to national associations that have entered at least one club in the 2023/24 UEFA Women's Champions League. The amounts paid to each national association will be based on the performances of their club(s) in the UEFA Women's Champions League. The national associations must then share the allocated amount equally amongst the clubs in their top domestic women's championship that are not competing in the competition. These funds will be earmarked for development purposes and may not be used for the fixed and ordinary costs of the club.

More detailed information about these payments and the criteria for distribution to clubs will be communicated in due course.

4. Surplus

The UEFA Executive Committee will decide should any revenue in excess of €24 million be available for distribution.

Please forward this information to the relevant stakeholders of your association, notably to the clubs competing in the 2023/24 UEFA Women's Champions League.

Written confirmation from UEFA's auditors that revenue generated by the competition conforms with the financial provisions of the regulations can be obtained from UEFA's finance division on written request, once the accounts have been audited.
