Estatutos de UEFA, Reglamento de Implementación de los Estatutos de UEFA y el Reglamento de Organización de UEFA

(Circular n.º 28/2024 de UEFA)

Por medio de la presente la RFEF comunica a todos sus afiliados el contenido de la Circular n.º28/2024 de UEFA.

Como podrán apreciar, a través de la misma UEFA informa de las últimas modificaciones aprobadas en sus Estatutos así como en el Reglamento de Implementación y en el Reglamento de Organización de UEFA. Es oportuno señalar que dichas modificaciones entrarán en vigor el próximo 1 de julio de 2024.

UEFA Statutes (Edition 2024), Regulations governing the Implementation of the UEFA Statutes (Edition 2024) and UEFA Organisational Regulations (Edition 2024)

Dear Sir or Madam,

On 8 February 2024, the UEFA Congress approved several amendments to the *UEFA Statutes*. As a consequence, the *Regulations governing the Implementation of the UEFA Statutes* and the *UEFA Organisational Regulations* had to be amended to be in line with these statutory amendments. Moreover, taking advantage of this revision process, a few other amendments were proposed to the *UEFA Organisational Regulations* to smoothen certain processes and to align with current practices.

Accordingly, the UEFA Executive Committee approved, at its meeting in Dublin on 22 May 2024, the revised *Regulations governing the Implementation of the UEFA Statutes* (Edition 2024) and the *UEFA Organisational Regulations* (Edition 2024), both of which will replace their respective 2020 edition.

The *UEFA Statutes* (Edition 2024), the *Regulations governing the Implementation of the UEFA Statutes* (Edition 2024) and the *UEFA Organisational Regulations* (Edition 2024) will all come into force on 1 July 2024. We are pleased to enclose the amended version of these documents.

A. UEFA Statutes (Edition 2024)

For a summary of these amendments, we refer you to the enclosure to our circular letter No 04/2024 of 23 January 2024.

B. Regulations governing the Implementation of the UEFA Statutes (Edition 2024)

The *Regulations governing the Implementation of the UEFA Statutes* (Edition 2024) containing the amendments which were approved by the UEFA Executive Committee on 22 May 2024 in Dublin are included in the *UEFA Statutes* (Edition 2024) (see letter A. above).

C. UEFA Organisational Regulations (Edition 2024)

The amendments to these regulations revolve around three pillars:

- (i) changes deriving from recent amendments to the UEFA Statutes (e.g. replacement of the Professional Football Strategy Council with the UEFA Convention on the Future of European Football, the removal of the age limit for committee and panel members or changes of terms, such as "chairman"/"chairmen" to "chair"/"chairs");
- (ii) alignment with current practices (e.g. change of name of certain committees, adaptation of the tasks of several committees and expert panels, role of the administrator in relation with expert panels); and
- (iii) clarification and smoothening of processes (e.g. clarification on the UEFA subsidiaries, clarification on the European Club Association and European Leagues representation on the UEFA Club Competitions Committee following the restructuring of the UEFA Club Competitions SA, clarification of the tasks of the UEFA Club Competitions SA, extension of the role of the Anti-Doping Panel members and simplification of the administrative process related to committees).
